CANNOT VIEW BID UPLOAD FOLDER

If a bid was submitted and the specified bidding folder didn't exist, the system was creating the incoming folder as a root folder and causing the folder to be unable to be displayed in the folder tree. Now the folders are created in the correct way and a data fix was applied to correct the already missing folders.

When a user attempted to save a new BI report from a BI dashboard visualization, the report would error instead of saving. Now, the BI report will properly save.

INVALID COST CONTROL ERROR FOR MASTER INVOICE IN RECEIVED STATUS

First round of cost control validation works fine when the status is turned to receive in an instance. At this point the invoice item amount is added to the budget Cost summary 'Actuals received' column. Now, in the next instance step when an action is taken, the cost control checks are fired again. Here the Updated cost summary 'Actuals Approved' column value is considered in one of the formula which is throwing a validation error.

ERROR WHEN OPENING COMMIT

When a commitment line item custom field was named the same as a column in the commitment line item or commitment change line item grids there could be an error when attempting to view the page. Now, commitment line item custom fields can be named the same without producing this error.

Expand all folder settings was not working in documents module. Now folders appear expanded or collapsed according to user's preferences.

ANNOTATION ICON MASKED DATE STAMP

Previously when a stamp with the following settings is created on a pdf file, the annotation masked the date. Now the code is fixed so that the annotation icon does not mask the date.

UNABLE TO DOWNLOAD ALL FILES WHEN A SLASH "/" IS IN THE NAME

The code wasn't checking for possible characters that the file system doesn't allow, like the slash. This has been adjusted to the characters are addressed.

Previously, instances submitted to a project for the first time were starting with an instance counter of 0 instead of 1. Now, instances will start at 1 as they should.

CSM: MODULE INTEGRATION DESCRIPTION FIELD NOT UPDATING

The dynamic line item description field was not updated when changing the line item value. Now the description field is updated when we select a different line item from the combo box and the value is also saved to database.

Before, when using bulk edit of project, the page would show an error on save if any custom field had an apostrophe in the description. Now, there is no error and the save is successful.

The Project Number Custom Field select was showing all the Project Custom fields with type of string. Now the custom fields are properly filtered.

The Custom Columns formula was not appearing in the column. The solution was to add a condition that execute text information into the column.

TAXES ARE NOT DISPLAYED ON CR FOR MULTIPLE PROJECTS

The Construction Reports on IO were not showing the taxes. There were new requirements on how these taxes should be calculated and changes to the report templates. This has been fixed.
