| 319182 | Resolved an issue caused by a typographical error on the Users Custom Fields REST API. The custom field is now loaded and displays the information correctly. |

AppXchange

| 328400 | Resolved an issue with the "Funding Source - GET" API schema that was caused by an invalid model definition. Now, the funding source object is successfully imported in Boomi. |

| 328396 | Clarified the error message received by a bidder attempting to submit a bid after the deadline. |

| 315169 | Previously, approving a commitment change was throwing an error due to duplicated new scope commitment item numbers. Now, the system shows a message about the duplicate line item number and disallows approval. |
| 318022 | Resolved an error with rounding-off the data on the downloadable Schedule of Values worksheet. |
| | On the Start Process or Instance Details page for a Commitment Invoice process for a commitment with a Commitment Type for PayApp (Not ProjectSight SOV) and for Lump Sum, the downloadable spreadsheet will now have proper rounding to 2 decimal places including the column 'Retained This Period' (except for Retainage Percentage which should round to 4 decimal places). |
| | Unnecessary calls to Excel formula functions 'ROUND' and 'SUM' were also removed. |
| 329104 | Resolved an issue that prevented users from submitting invoices against master commitments without errors. When Project Commitments are approved by process, the Master Commitment Items' amounts should now be set to the Project Commitment Items' amounts instead of remaining zero. |
| 329263 | An error was displayed when trying to edit a budget line item. The system will not consider spaces as valid characters for segment codes. Now, a trim will be made to avoid spaces in those fields. |
| 330747 | Resolved an error that prevented users from being able to use a Commitment Change process import properly. |
| | The changing amounts were being incorrectly validated against the cost controls when the Commitment Change process imports took actions that changed the status |

to void from draft or pending. Now, cost control checks are skipped when voiding a draft or pending Commitment Change Process through an import.

| 326021 | Resolved the issue by correcting the order in which the item is being selected. The issue was the [last created commitment item was selected by the code step]. This applies to all uses of this code step. |

| 326861 | Resolved an issue where dragging a folder with files for uploads caused intermittent errors when there is network latency. |
| 331780 | Resolved an issue where customers were able to see the names of folders to which they did not have access. |

| 328651 | The project zip code field has a maximum length of 10 characters. Data validation has been put in place to ensure that this is not violated. This applies to all uses of this code step. |

| 329502 | Resolved an issue where the validation failed in the code step: Approve CCOPs. Improved the SQL statement to use just the needed columns. |
| 336796 | Fixed an error that occurred when accessing the 'Attached Documents' tab on the Start Process function for a commitment Invoice. |

| 327937 | Resolved an issue with a field not being displayed when trying to add a formula column. In the Reports module, the custom fields drop-down list in the formula creation/editing form was missing fields of the "aRoleMember" data type. |
| 328835 | Resolved an issue that prevented users from being able to sort a BI Report. This has been fixed and users are now able to sort and filter by those date fields properly. |
| 329149 | Added a check to the export to Excel to utilize different settings if the report column is grouped by year. |

| 326029 | Changes made to the working time were not applying after saving them. Resolved this issue by fixing the working time conversion to save to and load from UTC according to the user-defined time zone. |
| 328424 | Resolved an issue that incorrectly allowed users to paste data into un-editable columns. Now, users will not be able to paste data into those columns. |


