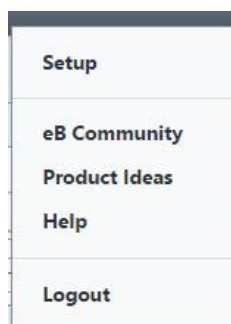
About the December 2018 Maintenance Release

294563	Resolved an issue where the Net Actuals Approved value was not taking into account Retainage Released.
292732	Resolved inconsistency with changes to commitment items on pending or projected commitment changes in cost processes to match cost module.
290186	Resolved an issue where string type custom field values were being changed to upper case when saving commitment items.
291273	Resolved an issues where forecast snapshots could incorrectly save project commitments as zero in certain situations.
268295	Resolved an issue where the user may not be able to scroll the commitment items grid from a mobile web browser.

295970	Resolved an issue where a new version of a stamped file was not being saved correctly in a data field.
296042	Resolved an issue where the download of a dynamic grid was not registering as the correct file type when using the Firefox browser.
293449	Resolved an issue where a custom process view was not returning the proper value for Responsible Actor in certain situations.
285047	Resolved an issue where a user could receive the same notification multiple times in certain situations.
277001	Resolved an issue where a process notification that included attached documents and was set to "archive as comment" could produce duplicate pages in the attachment.
299733	Resolved an issue where a custom process view setup to display processes with no actor would not display the correct results based on the filter values.

294382	Resolved an issue where a report containing formulas with division could produce an error "There was a problem with this report" in certain situations.
