## Resolved Cases

### AppXchange

Case #	Resolution Notes
303088	Query APIs were updated to handle apostrophes in custom and process data field names.

### Bidder Portal

Case #	Resolution Notes
303111	A browser-specific error was occurring in Mozilla Firefox that prevented the calendar icon from working. This has been resolved.

### Bidding

Case #	Resolution Notes
288850	Documents attached to bid submission custom fields were not being shown on the bid tabulation sheet. These files are now displayed if the Bid Tabulation option is enabled to display the custom fields.
288850	Bid submission custom fields of the "file" type were not saving the uploaded files to the destination folder path specified in the custom field setup.

### Business Intelligence

Case #	Resolution Notes
294318	Performance has been improved to index large BI reports or complex queries.

## Calendar

Case #	Resolution Notes
301305	The mail merge output for a particular event showed an extra empty chart that was not included in the mail merge template. This issue has been resolved.

## Cost

Case #	Resolution Notes
301160	An error was produced when selecting a cash flow that had line items linked to deleted tasks in the schedule. Now, the tasks in a schedule cannot be deleted if they are linked to cashflow items.
299938	In the Budget Change grid, users without "add/edit budget" permissions were unable to use the Formula Builder. Now, any actor within the step of a budget change process can use the Formula Builder.
299731	Payment application commitment invoices now accept negative values for line items.
297986	Resolved an error when approval of a pending commitment change with \$0 line items (where commitment settings do not allow \$0 line items) incorrectly added the \$0 line items to the Master Commitment.
301997	The Unit of Measure value can now be edited on approved commitments.
303683	The Edit Commitment Item page will now stop the user from changing the funding to a funding source that does not have sufficient funds.
303845	The date of the invoice recorded on the Funding Sources details page now shows the date that it was approved, and there is no time zone conversion calculated.
303826	Parentheses are now handled in the process lookup tab name.

Case #	Resolution Notes
281545	Resolved an issue that caused distorted formatting of PDF documents when opened with the Stamp tool.
293566	Resolved the File Not Found Error displayed when uploading folders with subfolders to the Documents module.
297989	Removed the ability to select redundant email property options.
297846	Corrected an issue where the Public URL, on some occasions, would show the incorrect file listing for a folder.
300125	Resolved an issue that prevented files with the same name from being versioned correctly when uploaded to the Documents module.
295074	Resolved an issue that prevented the uploading of large files.
300488	Resolved issue of duplicate file names in the upload window, when uploads do not execute to completion.
303159	Resolved error where the deleted folder is present in the Folder view in the Documents module.
304012	Corrected a versioning error due to system latency.

## Master Contract

Case #	Resolution Notes
302510	Pending and projected project commitment changes were not updating the master commitment cost summary. This issue has been resolved.

## Mobile App

Case #	Resolution Notes
277405	Resolved an issue where CC emails were not being generated when a form was posted by the mobile app.
293651	Resolved an issue where hidden fields were shown in the dynamic grid.
293654	Resolved an issue where a dynamic grid was shown although it was not included on the step layout.
293662	Resolved an issue where page layout headers were not displaying correctly on the mobile interface.
294163	Resolved an issue where the app allowed users to enter values that could not be saved.
293652	In the dynamic grids, required fields are now identified by red asterisks (*). This is consistent with the way in which the required grid fields are displayed when viewed in a desktop web browser.
293656	The dynamic grids in the Daily Field Report processes are now listed in the order in which they are configured in the page layout. This is consistent with the order in which the grids are displayed when viewed in a desktop web browser.
295564	Resolved an issue where certain users were unable to use the Add feature within Processes in the Mobile app.

## Processes/ Workflow

Case #	Resolution Notes
299782	Resolved an issue that required create permissions to upload files to the default destination folder.
298293	Resolved an error on dynamic budget line items processes where an instance with empty line item cannot be saved or submitted on any step.
296147	Resolved an issue that prevented escalation rule email notifications from being sent.
297176	The dynamic grid was not displaying correctly if it included a column name containing an ampersand. This issue has been resolved.
299590	For dependent processes, the Lookup Column Width configurations were not being recognized and could result in an extra blank column. This issue has been resolved.
299779	Resolved an issue where escalation rules failed to send email notifications.
300348	When duplicating a process instance of a Commitment Invoice, the invoice amount was incorrectly zeroed out if the submit action includes a confirmation panel and/or Add Comments option.
299166	Global custom fields were not honoring the "Allow Duplicates" setting for process data field assignments. This issue has been resolved.
301413	When duplicating a process containing a data field name with an apostrophe that is being used as a process lookup field, the system was throwing an error.
302841	Imports to commitment invoice processes were sometimes failing due to an incorrect validation of required fields. This issue has been resolved.
257433	Resolved an issue with the process filter page where searches starting with numbers or containing a dot "." were not included in the search results.

## Reports

Case #	Resolution Notes
300497	Removed the availability of budget custom fields for filtering on non-cost reports to avoid errors on running the report.
301396	Fixed an error where a link inside a Calendar report was returning the incorrect instance of the meeting series.
301797	Fixed an error where a report filter "not equal to" on a multi-pick field was not returning correct results.

## Schedules

Case #	Resolution Notes
298506	The calculation of Start Variance was using the start date of the schedule, which can be different than the rolled-up date from the tasks. Now, the Start Variance is calculated using the rolled-up start date from the tasks.
298998	When the 'Automatically calculate the % complete' setting was enabled, and the tasks are calculated to 100% complete, it was still displayed as being in the court of the user on the home page. Now, tasks that are complete are properly excluded from the user's court.
301699	There were issues with completed tasks (100%) and how certain fields were updated. Completed tasks are now updated correctly.
302304	The snapshots of Start and Finish dates were not reflecting the snapshot tasks start and finish. This issue has been resolved and snapshots of the Start and Finish dates properly reflect the earliest start and the latest finish of all tasks in the snapshot.
301676	Resolved an issue where task updates in the schedule were failing due to improper constraints.
302858	Resolved an issue where the critical path was not including some parent tasks.




- 301906 Resolved an issue where task updates in the schedule were failing due to improper constraints.
- 304246 When loading a task's description with links or emails tags, it was duplicated and prevented the schedule from loading. This issue has been resolved.
- 302597 Resolved an issue where edits to the task description using the task editor were not saved.

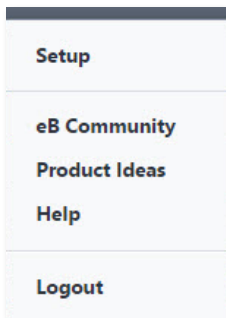
### Setup Admin

Case #	Resolution Notes
301822	Global custom fields of "string" type that were configured to "Do not allow duplicates", were still saved as duplicates when using apostrophes. This issue has been resolved.
302024	Resolved an issue where project numbers that were automatically set by the system upon project creation were not being consistently generated, and users had to manually enter their project numbers for some projects.
