e-Builder quarterly enhancement releases include improvements to targeted areas of product functionality and usability enhancements that increase the ease-of-use of current features and functions across the entire product. This release also includes a list of resolved cases for the past month.

What's New

Resource Management with Cost

e-Builder is excited to introduce Resource Loaded Schedules linked to the Cost module in real-time! We have augmented our new Schedule interface by adding a new Resource Management with Cost module to solve the following problems facing our clients:

- Need a simple way to accurately assess the organization's self-performance costs over time.
- Project Managers have no visibility into the Planned Hours of their professional and associated Costs on Task assignments. They often don't see such costs until <u>after</u> the charges are billed to their projects via Payroll Journal Entries.
- Project Managers face challenges in accurately forecasting their Resource Cost at Completion due to lack of visibility into their true Remaining Resource Costs.

The new Resource Management with Cost module solves these problems by providing clients with the ability to:

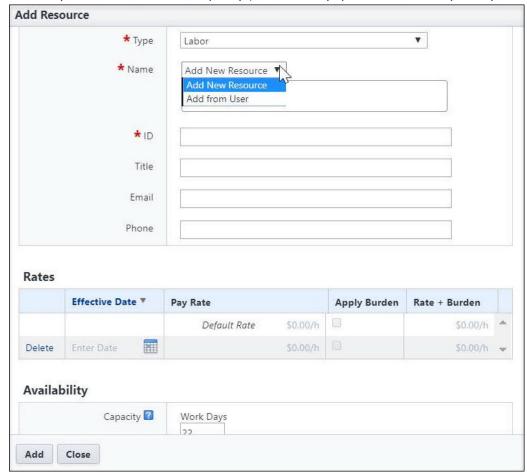
- Capture accurate resource costs Easily and consistently capture accurate resource rates for staff, apply the labor burden, and then load resources onto tasks. Project Managers will not have to use "ballpark estimates" or "rule of thumb percentages" to assess self-performance costs any more.
- Link resources or schedule tasks to budget line items At the project level, select whether to link schedule tasks or link resources to budget line items, and view real-time resource costs in the project Cost Summary.
- **Eliminate hidden soft costs** With visibility of resource costs in the project Cost Summary, managers can evaluate their true available budget for external contracts.
- Track remaining resource costs as payroll costs are entered As actual payroll costs are entered from the ERP system, remaining resource costs adjust accordingly, providing highly accurate total project cost at completion.

New "Manage Resources" page in Admin Tools\Schedule

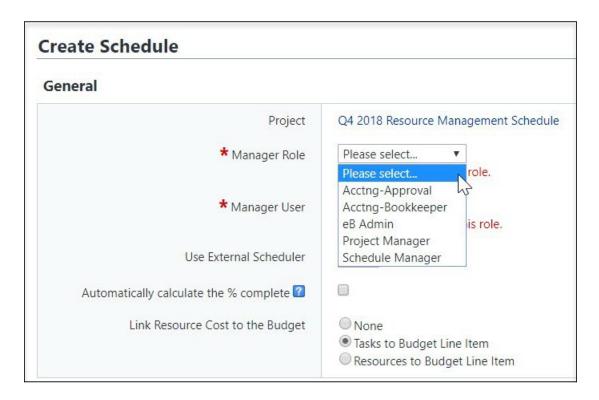


When Adding Resources, select any Account "Users" or "Create New Resources" (non-users)
Enter Pay Rate, Effective Date, Capacity (i.e. Work Days per month, Hours per Day, Max Allocation %)



For any Project, Resource Costs may be linked to the Budget either by:

- Linking Tasks to Budget Line Item, or
- Linking Resources to Budget Line Item

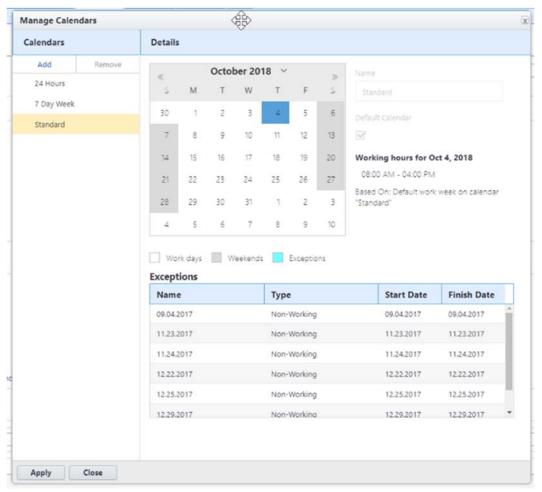


Multiple Project Calendars

There are 3 pre-defined Calendars with 3 different Work Weeks

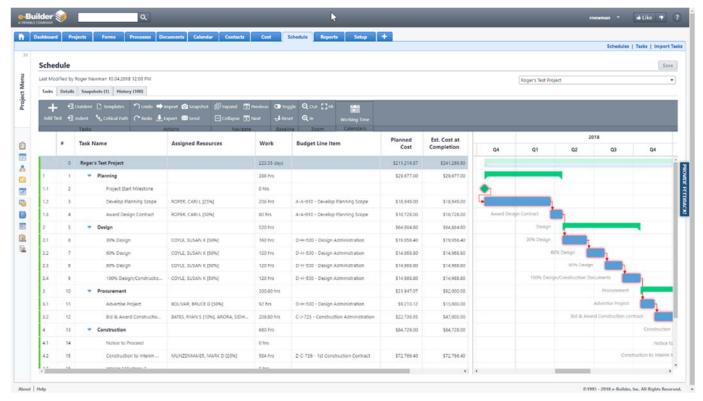
- **Standard:** Monday to Friday (8 hours each day)
- **7 Day Week:** Sunday to Saturday (8 hours each day)
- 24 Hours: Sunday to Saturday (24 hours each day)

Additional Calendars can be added and may be selected for use on any Task in the Schedule



Manage Calendars window

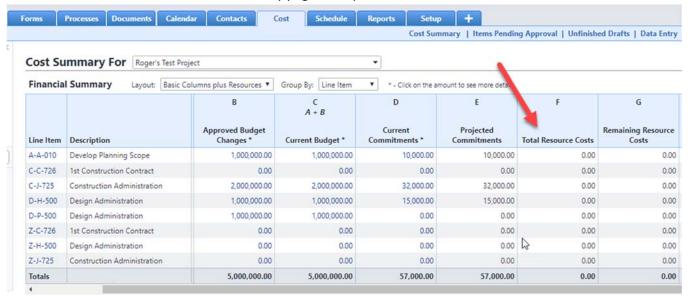
Schedule Gantt Chart with Assigned Resources and Links to Budget Line Items

New "Total Resources Costs" Column

Once the resources or tasks are linked to budget line items and the schedule is saved, the new "Total Resource Costs" is visible in the Cost Summary page and updates in real-time to match the schedule.

New Gantt Chart Columns

As part of the enhancements and available with Resource Management with Cost, new Gantt chart columns were added to resource management. See the Online Help for more information about the columns.

Disallow Negative Budget Items or Negative Budgets

E-Builder has added the capability to prevent users from requesting approval and approving Budget Items or Budget Changes that will result in a negative Budget Value.

- If Budget Control is set to "Controlled by Line Item", users will receive an alert when attempting to approve a Budget or a Budget Change that results in any Budget Line Item Value < \$0.00.
- If Budget Control is set to "Controlled Total", users will receive an alert when attempting to approve a Budget or a Budget Change that results in the Project Budget Value < \$0.00.

To begin enforcing this new control on all transactions going forward, contact e-Builder's <u>Technical Support</u> to set the new Account Attribute to "DisableNegativeBudget".

Formula Update for "Net Actuals Approved"

The formula on the cost summary column "Net Actuals Approved" has been updated. Previously, the formula did not consider retainage release amounts in the "Net Actuals Approved" column, while it was considered in the "Net Actuals Paid" column. This resulted in discrepancies between "Net Actuals Paid" and "Net Actuals Approved" following retainage release transactions.

The Net Actuals Approved formula has now been updated to include retainage releases.

Net Actuals Approved = Actuals Approved – Amount Retained + Retainage Released

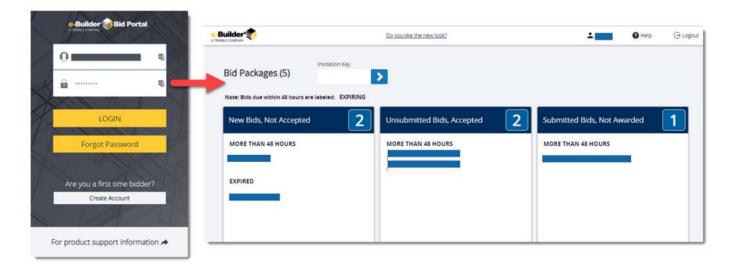
Updated Bid Portal User Interface

The Bid Portal has been streamlined to ensure that all bidders have the timely information that they need to prepare competitive, accurate bids in high-stress environments. This includes the following updates:

- An updated user interface for the Bid Portal where the bid submitter's key information is highly visible, and where the final bid takes only a few minutes to prepare and submit.
- A user interface that increases the confidence of the bid submitter that they are competing on an even footing with other bidders, and that their anonymity is protected.
- A user interface that clearly communicates the documents, addenda, and clarifications published by the bid manager to all bid submitters simultaneously.

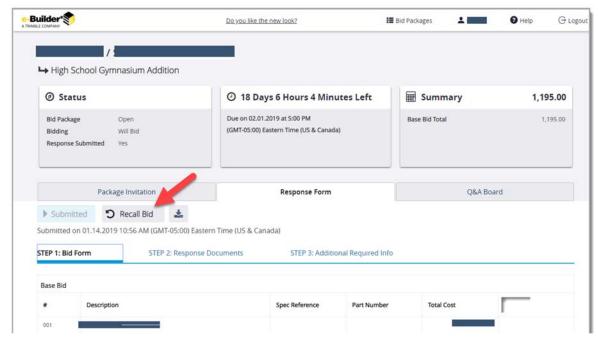
Considerations

- The e-Builder Admin for each customer must contact <u>Technical Support</u> and request to activate the new interface.
- All bidders will encounter the updated Bid Portal login screen and main Bid Packages listing
 page. Once the bidder selects a bid package, e-Builder will present the new or legacy interface
 depending on whether the account setting has been activated.

- Recall Bid: Only change in functionality. This feature allows bidders to recall, edit and resubmit
 their bid response at any time prior to the bid due date/time without requiring approval from
 the bid manager.

Bid Package History – Pending Requests

The Bid Package History tab now records the bid manager's approval or rejection of pending requests for access to bid packages from uninvited bidders, or for re-opening bid packages.

"Create Submittal" Permission - Blocked from Hidden Items

Hidden comments and attachments are intended to be viewable by the design team for submittal review conversations, and then selectively shown by the submittal coordinator to the construction team (typically using Create and Add/Edit submittal permissions). The new "Create Submittal" permission added in 3Q2018 was incorrectly able to view hidden items, and this has been fixed.

Companies/ Contacts

Case # Resolution Notes A change was made for Process data fields, in particular- of types "Company" and "Company on Project". When a company is either NOT Active or has the "Do not use" checkbox unchecked, then the name of the company will not appear on the process instance while clicking on the lookup button for the data field. For a company to appear on the lookup, it must be either "Active" or has to have the "Do not Use" option not selected.

Cost

Case #	Resolution Notes
291129	When importing a Cashflow Curve with less than 200 data points, the resulting curve was vaguely accurate to the intended curve. Now the curve matches the intended curve.
291622	Previously, the General Invoice Import didn't include each new invoice's cost against overall project current commitments causing commitments to exceed budget when the budget was controlled total. This has been corrected.
296406	Earlier, marking a budget approved while an Apply Template is running could cause the resulting Budget to not appear to have any items. Now the budget status is checked before applying cost summary changes to budget when applying a Template.
	Controlled Total Master Commitments would not draw down Master Commitment Items beyond their amount causing Project Commitment Changes to increase the value of Master Commitment when the value of the Project Commitment Item exceeded the Master Commitment Item. This has been corrected and Master Commitment Items can now go negative with Controlled Total setting.

Case #	Resolution Notes
297730	A browser-specific error was occurring when using IE11 and editing a notes field in a process, causing the changes not to save. This has been resolved.
Forms	
Case #	Resolution Notes
299880	The Form Types Properties Page had consistent slow performance. Code optimizations have resolved the performance issue.
Processes	
Case #	Resolution Notes
296051	The "Last Modified Date" on Project Details was not updating when a project custom field was updated via a data field assignment in a process. The LastModifiedDate is now being updated as well as the Audit Log record.
283910	Previously, the system was not showing the Commitment Retainage Percent mapping field. Now, the system works properly.
297704	When a process had multiple dynamic grids on a page with cost items and a shared grids configuration, an error could occasionally happen blocking the process. The underlying conflicts of having multiple dynamic grids and cost items have now been resolved.
296162	When using the workflow designer and saving a workflow, the designer would adjust the view extents around the workflow, though the left alignment could cause some text to not be visible. The adjustment of the extents has been modified to have more room around the diagram to lessen the possibility of hiding arrow text on the left side of a diagram.
294852	Fixed sending notifications to past process actors who are no longer on an account.

- 292522 Previously, the system was throwing an error when trying to add items from a dynamic commitment line item process if the commitment is connected to a master commitment. This issue was due to it missing the call to the service that handles master commitment. Now, the system works properly.
- 217163 Budget Changes were incorrectly being approved when it would reduce the budget less than Actuals Received. Now the validation enforces that budgets cannot be less than Actuals Received, which is the sum of Received Commitment Invoices and Received General Invoices.

Reports

Case #	Resolution Notes
299972	When accessing the standard cost report and clicking through the hyperlink on "Actual Approved," the user would be misdirected to the wrong page. The link has been corrected to the "Actual Cost" tab view.
297507	When a user exported a report to Excel with negative values, the numbers were recorded as text values instead of numeric. This issue has been resolved.

Search

Case #	Resolution Notes
296874	When performing a document search, results appeared to be incorrect because of the treatment of a whole word. For example, the search was treating 'Elevators.pdf' as a whole word and 'Elevators' as part of the word. An update has been made for the search functionality to work with part of the word.
298102	When using global search, an error was occurring when users would attempt to download search results containing 'null' field values. This has been resolved.

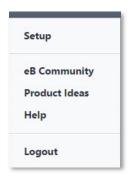
Submittals

Case #	Resolution Notes
296818	External users who were cc'd on a submittal may have had incorrect editing capabilities on the Documents and Comments tabs (including Attach Revision and Redline links). These tabs have been fixed to reflect the same permissions as the Attachments tab.
